Forms of evaluation

The course has been evaluated through both oral and written assessments. The written assessment was based on six standardized questions (see below) and the oral assessment was conducted at the final seminar of the course (as well as continuously in relation to the regular seminars).

Summary of the students' course evaluations

In general, the students were very satisfied with the course. They also appreciated the mix of students, where most were from the MA program in educational theory and some took the course as an elective. While some students found the readings difficult (especially the primary sources) most found that the introductory lectures were helpful for unpacking it. Some students also found that there was a gap between the framing of the course as a course in political philosophy and education, and the assignment focusing on policy analysis.

In the summative question concerning to what extent the students found that the course as a whole had met with their expectations (on a scale of 1-6, 1 being the lowest and 6 the highest), 8% answered 3, 31% answered 4, 38% answered 5, and 23% answered 6. Below follows a selection of student statements about the various aspects of the course sorted according to the questions asked in the written evaluation.

1. What do you think of the structure of the course?

Summary of the evaluations of the teaching team
