Overall, the students seem to be pleased with the course, the different learning activities and the variation of tasks given to them. Based on the survey the majority seems to have appreciated the

course. However, there are some issues that needs to be dealt with in the development for next year that has to do with the order of the different seminars as well as the focus on the group work to provide more time. There was also comments around online, although the course is campus course only this might be something that could be addressed and will be further developed in the analysis. Finally, the students have taken responsibility for their learning and general outlook is that the course have provided multiple learning opportunities.

Summary of the teacher's views/Results: (The comments on the course's implementation and the results based on an assessment of the students' actual learning outcomes in relation to the intended learning outcomes, are summarised here. Both success factors and problems are identified).

Overall, the course has been running rather smoothly. The main issue is as always, the Christmas break and having an elective course with exchange students that might leave for their home countries in December creates a bit of pressure in how to organize the course. There were also comments in the evaluation on the order of the two elective courses and the students view on how they might be given in the opposite order to make more sense. However, this is based on students that actively chose to take both courses. Regarding the input on seminars and more focus on the project work there is a plan to adjust the order of the seminars to better align with the development of the projects. A change was made from last year to this year so that the seminars better followed the project but there is still room for development. From the teacher point of view the course have been running well and there has been on average 22-24 students during the lectures and around 30-35 during the mandatory seminars. The main issue we see is that students are taking up to 30 ECTS at the same time during the second half of the semester at different universities, which create clashes in the schedule for them. This is problematic when having several seminars and group work, which in some cases lead to dysfunctional groups. To conclude the course has been good and the core group of students have been active and performed well.

Analysis and action plan (To be completed by the course coordinator)

Main developments and issues during this year:

+ Better flow and alignment between the four individual seminars and the project work in topicality, allowing the students to develop knowledge and skills in relation to the project work. A good combination of entrepreneurship and international strategy in the seminars.

- The order of the seminars needs to be changed for next year as the students felt that some of the seminars came too late and some came too early. The same with the different lectures where the topics of international strategy could be moved to a later stage to better align with the flow of the project.

- Some comments on the availability of online lectures (resulting in low scores). But the course is an on-campus course, and it seems like an unfounded negative critique.

- Some issues with seminar instructions for seminar 1 and 3 in particular that needs to be handled better next year.

For the coming year the order of the seminars will be developed to better align with the entrepreneurial project. The focus on strategy and internationalization will be moved later in the course so that the students will face that part when they are getting into that phase in their group work. On a more long-term plan, perhaps the idea of some sort of hybridity regarding on-campus and online could be a potential to open up for students to take part and only be on campus for some of the mandatory seminars. Finally, a main issue has been the broken semester with Christmas break and how to structure the different learning activities and also exams. Until now the final exam has been a take-home exam after Christmas, but given the role that Ai is having today on learning there might be a need to rethink how the individual exam should be arranged and it is something that the teaching team is thinking around ongoing.
