Summary of the teacher's views/Results: This was the first time we had the methods course in this format, running it together with the MA program in migration (IMER) and there are reasons to consider links between elements of the course. There are also reasons to look at the interface between the methods course and the thesis course. This applies especially to the one-year program. Program representatives have brought up the point that better integration would be advisable.

Analysis and action plan (To be completed by the course coordinator)

Analysis: Some of the issues relating to the interface between the methods course and the thesis course concern administrative questions, such as registration. This is now fixed and hopefully this gives students earlier access to the thesis course. There are also reasons to consider moving the thesis draft seminar to an earlier point in time so that better integration between the two courses can be achieved.

Action plan: Administrative questions affecting the relation between the methods course and the thesis course have been addressed. Further questions about the integration between thesis and methods course will be addressed will be addressed at teacher's meetings in the spring and the fall.
