Forms of evaluation

There has been an ongoing formative discussion during the course. The summative course evaluation was conducted in Reflex.

Summary of the students' course evaluations

The students are satisfied with the course. In the evaluation, they give a rating of 5 or 6 (on a scale from 1-6) for all questions except in one case where the learning materials received a rating of 4 from one student. This student expressed a desire for additional examples and templates to aid in the overall learning



process. However, all students gave a rating of 6 for the course's ability to provide opportunities for them to take responsibility for their own learning.

The students have especially appreciated the connection to the master thesis and the possibility to freely choose topic and to make a thorough inquiry into the literature in the field, the personal experience/examples, the flexibility and informal way to discuss what is expected from the examination assignment. Participants appreciated discussion and feedback in a very small group. The course position, being the last one before the thesis, was also appreciated. One suggestion for development were having writing buddies that share and comment through-out the course and more formalised writing sessions.

Summary of the evaluations of the teaching team

It is the first time for this course, and parts of the design has been developed together with the course participants during the course. The design seemed to have worked well.

Analysis

There are several success factors; however, since this was a small group consisting of only 7 students, there is a need for some redesign to accommodate a larger group. The suggestions regarding writing buddies and implementing more structured writing sessions are very relevant and will be taken into consideration for the next cohort. As both the course leader and examiner, I can observe that the process and format for the final paper have resulted in exceptionally well-written drafts that could be revised into articles. This topic has been discussed within the group, and it has been recommended to the students to pursue this approach. Incorporating drafting for an article may also be included in the course design in the future.
