

COURSE REPORT – COMPREHENSIVE DOCUMENTATION OF COURSE EVALUATION The Faculty of Health and Society

14The work with course evaluations and course reports constitutes a part of the faculty's quality assurance work in education at first-cycle and second-cycle education. The course report is a comprehensive documentation of the course evaluation and is an important instrument for the development of courses and programmes as well as for guaranteeing the students' influence on these. The course report takes into account the students' course evaluations, the teachers' views on the course's implementation and the results based on an assessment of the students' achieved learning outcomes in relation to the intended learning outcomes of the course. Key figures, an analysis and a development plan for the course are also included in the course report.

It is of the utmost importance that students are given the opportunity to participate throughout the course evaluation process and that they make use of the opportunity to give constructive criticism. In this way, the results can serve as a relevant and specific foundation for improvement.

The structure for course evaluation is described in the "Course evaluation process for first- cycle and second-cycle education at Malmö University" (in Swedish *Kursvärderingsprocessen för utbildning på grundnivå och avancerad nivå vid Malmö universitet*, dnr. LED 1.3-2018/123) and in the "Routines for course evaluations and course reports at the Faculty of Health and Society", Ref. no. LED 1.3-2016/187.

The course report compiled after each completed (full) course forms the basis for feedback to students and is followed up at quality dialogues at faculty- and university-wide level.

Results: Comments on the course implementation and the results based on an assessment of the students' achieved learning outcomes in relation to the course intended learning outcomes are summarised here (incl. information regarding the result of the examination). Both success factors and problems are identified

This was the first year of the course.

Overall, the course report indicates that students were satisfied, as reflected in the "achieved intended outcomes" score of 4.6. Their evaluation of the "learning activities" was slightly lower at 3.7. The Examination was positively evaluated at 4.4, while the overall expectations were less favourably evaluated at 3.7. Conversely, "opportunity to take responsibility for your own learning" achieved a score of 5.4. Students also found the course to be very "research based" with a mean score of 5.1 and with a "reasonable" workload score, 4.8, and "student influence" score of 4.4. The "international aspect" is also evaluated favourably with mean score of 2.4, out of a maximum of 3.

From the qualitative comments:

Critical comments on the audio quality and relevance of the pre-recorded lectures. Student noted that there was overlap in the contents of these pre-recorded lectures and prior courses.

Analysis: Analysis based on a summary of the students' individual course evaluations – both formative as summative. Produced in collaboration with the teachers involved in the course, alternatively by taking their views into account.

As noted, this was the first year for this course. Overall, the scores are good and acceptable but three of the critiques in the qualitative comments need addressing.

- 1) The overlap with a prior course. This relates to the course on Life course criminology. It is my understanding that this course is no longer offered, and as such, the overlap will no longer be an problem from next year.
- 2) Low quality of pre-recorded lectures. This one is difficult for me as course coordinator. The prerecorded lectures were by the senior most professors at the institution. I am not going to tell them that they need to re-record lectures, and speak better English lol.
- 3) More "green criminology". There is a divide in the course between the first half, state of the art on life course, and the second half, current issues. See "course development" below.
