#### Response:

**Achievement of Learning Outcomes:** Students felt they had achieved the learning outcomes, with many rating this aspect highly.

**Supportiveness of Working Methods/Learning Activities**: Most students found the course's working methods and learning activities supportive in achieving the learning outcomes.

**Opportunity Given by Examination Forms:** The majority of students felt that the examination forms provided them a good opportunity to demonstrate their learning achievement.

**Meeting Expectations:** The course met the expectations of most students, with high ratings in this area.

**Opportunity for Personal Responsibility in Learning:** Students highly rated the course's ability to allow them to take responsibility for their own learning, indicating a strong component of independent learning.

#### Response:

The course was very affective and the adequacy of the course content successful, and the level of student engagement and learning outcomes was achieved. The success factors are seen in the final exams and exercises surrounding each learning activity.

#### Response:

Based on student feedback, the course seems to have been highly effective in several areas. Students felt that the learning outcomes were largely achieved, and the course's working methods and examination forms were supportive of their learning. The course's design and the tools provided (like Canvas and various Adobe, Figma and Canva assignments) facilitated a conducive learning environment.

Areas for Improvement: Students noted some areas needing improvement, such as better organizational structure within the course management platform (Canvas), and suggested more compulsory elements to ensure a thorough engagement with the course material.

Recommendations for Future Offerings: Improving navigational aspects of course tools, considering more mandatory elements to ensure consistent student engagement across all course topics, and possibly introducing advanced follow-up courses such as a Grafisk design och medier II could enhance the learning experience.
