25 students finished the course which is a marked decrease (in absolute and relative terms) from the two last years. The ones who did finish got satisfactory results however.

Students seem to enjoy the first module

There seem to be some problems with the latter two modules.

Of course certain conclusions cannot be drawn from one survey with a limited sample of respondents. However, it makes sense that there is room for improvement of the two latter modules, since these are the most connected to the problem of the teachers permanently tied to the programme not having enough hours to cover all the teaching at the programme, which requires engaging external teachers (who might vary from year to year). Even apart from that problem, the basic aim of having method and paper modules covering three different methodological perspectives would still be a very difficult challenge.

Ideally, it would be best to tie more teachers to the programme permanently. If that is not possible, some kind of semi-permanent solution would be best (where at least the same external teachers are recurring). There will be a need for discussing these issues between the programme and the department.
