However, some wanted more of a focus on humans, and on concrete cases. Also, some thought the first examination should come a bit later in the course. <p>Q1 mean 4,7 Q2 mean 4,3 Q3 mean 4,7 Q4 mean 4,4 Q5 mean 5,4</p>

<p>Summary of the teacher's views:</p> <ul style="list-style-type: none"> It is very difficult to draw conclusions from the limited number of respondents, although several of the ideas expressed by the respondents do make sense (e.g. more concrete cases, a bit too limited time for exam 1). As for the exams, answers were generally of high quality, as were seminar discussions.
