The students appreciated the opportunities to apply theory to specific cases as a way to practice and demonstrate the application of theories to practice. They liked the mix of individual and group work and the opportunity to have a case seminar with a sustainability director who is practicing in the field. They also appreciated the

investment of the instructors and the integrated assignment whereby they could apply their knowledge to a case. There were a few recommendations requesting more time for the final case to provide additional time for reflection and work as a group. They found the section on organizational aspects especially interesting and would have liked more time focusing on this content area. They expressed that the learning methods to a high extent reinforced their learning and ability to achieve learning objectives (especially the peer teaching). And to a large extent the course met their expectations.

### **Teacher's perspective (To be completed by the course coordinator)**

**Summary of the teacher's views/Results:** The intended learning outcomes with the primary aim of student capacity to demonstrate an integrated understanding of the individual, organizational and network perspective was mostly achieved as demonstrated in the results of the integrative paper and final case seminar. Student engagement remained high in the course with demonstration of application of theory to practice in the live case and the case seminar. There were some challenges expressed in the workload due to two courses running concurrently however most students managed to submit their assignments at the first-hand in. Areas for further development include an updated international case and for each of the modules to provide more time for discussion during class time supported by preparatory reading by the students.

### **Analysis and action plan (To be completed by the course coordinator)**

**Analysis:** This course continues to be a one where the students demonstrate their integrated knowledge from a critical perspective and in this way a summative assessment of their program knowledge. The learning activities provide the opportunity for them to demonstrate and reflect on their own growth and knowledge in relation to leadership, organization and sustainability. There were a few requests for clarity regarding the connection between communities of practice and an integrated perspective of leadership, organization and sustainability. When class time was provided to reflect and discuss the students used this time well however, the pre-reading required for critical, reflective discussions only seemed to occur when connected with an assignment such as peer teaching. It would be interesting to continue to explore ways for students to learn the module content areas out of class (e.g. pre-reading, video lectures) to facilitate more in-depth class discussion comparing, contrasting integrating the three perspectives in relation to each module.

**Action plan:** 1) Course coordinator will update the final case by the start of the Spring term 2023  
2) 1-2 online venues will be piloted to supplement face to face learning to provide course content preparation outside of class to free up additional class time for critical reflection and discussion – course coordinator and other primary lecturer in the course will share this responsibility. 3) In the lecture to make a clearer connection between CoP and an integrated perspective of leadership, organization and sustainability – lecturer responsible for this module.
