We have only 9 responses out of 40 for the online survey. This means that results cannot be seen as representative.

Qualitative answers are therefore most interesting. Among these responses are

- A suggestion for a smaller seminar for presentation and discussion with only one group or possibly a few. The respondent felt that the larger group did not contribute to quality in the seminar.
- Guest lectures on innovative methods would be a good addition
- More technical support would be advantageous primarily for capturing images and sound but also for presentation
- More support on working in groups would be helpful
- Some students indicate challenges in supervision but it is unclear exactly what the problems are or if this is shared by others.

Overall, we found that students have conducted good work during the course and experimented with alternate methods and topics in ways that are conducive both for further academic work. The process has been good but we would have liked to see more participation in studios. The budget was very limited which puts hard constraints on the number of lectures and seminars

The students have made good use of the course, however there seems to be need for improved communication internally and also some helpful texts. Getting better access to cameras and microphones would be helpful and this possibility will be explored but has previously proved challenging.

We will review the course literature and try to provide more examples of innovative methods. We will also see if we can include some useful texts on working and writing in small groups. A means of improving communication will be to employ amanuenses, preferably from the second year to conduct a student-led seminar.

In terms of managing expectations it is important next year to underscore student responsibility for organizing meetings with supervisors and to utilize studios. If the budget is less constrained next year a further seminar and and guest lectures can be included.
